1. Have you had your deed and plat recorded?

If not, you will need to have a deed recorded with the Hart County Clerk, along with a surveyed plat showing property lines and set back requirements. For assistance call the Clerk's Office @ 270-524-2751 or Hart County Planning Commission @ 270-524-1782.

2. Are you going to build in the city limits of Munfordville or Horse Cave?

If yes, Munfordville and Horse Cave have zoning regulations that may apply to you, and your project, for assistance call Munfordville City Hall @ 270-524-5701, Horse Cave City Hall @ 270-786-2680.

3. Do you have an address?

To begin the process, call the Hart County Court House @ 270-524-5219. Address is **required** for Building and Electrical Permits.

4. Do you have a septic tank release number?

To obtain a septic tank release number, contact Jason Meadows @ the Hart County Health Department @ 270-524-2511 Ext 3, environmental. **Required** for a Building and Electrical Permit. If you are connecting to city sewer with CEA please provide your Invoice.

5. Will you need a Plumbing Permit?

For information call 270-524-3509

6. Will you need a Building Permit?

YES, all dwellings require a Building Permit, barns and detached buildings such as a private garage on more than 10 acres do not require Building Permits. For questions call 270-524-1782.

7. Will an Electrical Permit be required?

YES, any electrical work being performed requires an Electrical Permit, and most electrical work requires a licensed Electrician. For questions call 270-524-1782.

8. Additional things you may need to know:

You may also need to contact the utility companies, such as gas, water, electric, and phone and set up accounts and inform them about your project. There are places in Hart County that do not have access to some utilities.

9. Before you dig, YOU MUST CALL 811,

Underground Utilities, such as Electrical, Fiber, Gas and Water, may be located where you plan to dig, hitting one could be both dangerous and costly. **IT'S THE LAW.**

10. Now that you have completed your home or have acquired a property, you will, in accordance with KRS 132.220, need to report it to the Hart County PVA, they can be reached @ 270-524-2321.
